VACCINE CLINIC WRAP-UP UPDATE:

As reported last week, Kona Community Hospital is in the process of wrapping up our public vaccine clinics. We will cease vaccine operations at the Kona Aquatic Center Gym as of Friday, May 28. Unfortunately, Premier Medical Group will not be able to take over administration of the Pfizer vaccine from KCH at this time. A revised timeline is below.

Revised Timeline & Logistics:

- May 20 (Thursday): Final clinic day at the Kona Aquatic Center Gymnasium
 - o 1st doses will be administered through final day in May. 2nd doses will be administered by KCH on June 17.
- May 28 (Friday): Final clinic day at KCH campus
 - o 1st doses will be administered through final day in May. 2nd doses will be administered by KCH on June 17.
- June 17 (Thursday): On KCH campus 2nd doses only at this clinic.
