B. Spec section 01715 refers to "Limited Hazardous Materials Survey Kona Community Hospital" prepared by EnviroServices & Training Center, LLC. The report is not found in the RFP, please provide a copy the report.

Spec section 01715 will be removed from the specifications. No hazmat report will be provided.

C. Louvers on drawing notes are calling to be hurricane rated, the spec is calling model EME420DD which is not hurricane rated. Please confirm if hurricane rated louver is required.

The basis of design was the Ruskin Louver Model EME420DDE. The specifications incorrectly show it as the EME420DD. Contractors to use Model No. EME420DDE for pricing purposes.

D. Please confirm if resumes of the project team should be included in the personnel section.

Resumes are not required, however if you want to include them, place them immediately behind the Subcontractor Table

E. Page 114 of 743, Section 00700 General Conditions, 1.01 B. The GENERAL CONDITIONS and SECTION 00800 - SPECIAL CONDITIONS shall govern the Work specified in all DIVISIONS and SECTIONS. Confirm when SECTION 00800 SPECIAL CONDITIONS will be provided.

Remove reference to "SECTION 00800 - SPECIAL CONDITIONS" and replace with "SPECIAL CONDITIONS".
