1. Addendum 1 provides the following questions submitted by Offerors and corresponding answers provided by KCH:
 - a. I have reviewed the RFP for the replacement wastewater treatment system (RFP HHSC 26-0259) and am emailing to see if you are accepting substitution requests for the package wastewater treatment system.
No substitutions will be accepted.
 - b. Regarding Item Nine (9) on the Proposal Schedule, which states “12” DI sewer line, including trench, pipe, and fittings, in place complete,” GBI is requesting clarification on the following:
 1. The proposed location of the sewer line, and
 2. A profile of the proposed sewer line, including relevant elevations and alignment.*Proposal schedule will be revised to show 6” DI Sewer line, instead of 12” DI Sewer line.*
 - c. Please provide a plan and profile for the proposed 6” sewer line and manhole, including the alignment, elevations, and relevant construction details. Additionally, provide tie-in information for the 6” outflow line, including the connection point, invert elevations, and any applicable specifications or standards.
The 6-inch sewer line will be located on the effluent side and buried 18-inches below the finished surface, extending toward the new sewer manhole and continuing toward the tie-in (see attached Exhibit.D) The Contractor shall field-verify the invert elevation and location of the existing 6-inch sewer line.
2. Addendum 1 provides the revised Proposal Schedule which reflects the change to 6” sewer line. The Word document is posted on the KCH Procurement page.
3. Addendum 1 also adds a bid security requirement. In accordance with section 2.8 of the 1999 Interim General Conditions, a bid security of 5% is required to be submitted with your proposal. Electronic copy should be submitted with your proposal with original delivered to KCH attn.: Contracts Dept within 3 days of proposal due date.
4. The Word document of the updated Proposal Checklist is posted on the KCH Procurement page.
